

RFBR Terms and Conditions for SIAM Journal Trial Participants use of SIAM content platform

By using the content platform of the Society for Industrial and Applied Mathematics (SIAM), any SIAM Journal Trial Participant hereby agrees to abide by the following terms and conditions –

Authorized Use

SIAM Journal Trial Participants may, for the established time period of their trial:

- a. make searches of the content.
- b. make one hard copy of the output of any search; such hard copies may be shared with nonauthorized users, provided such sharing is for the purpose of scholarly communication or educational use and there are no commercial benefits. Trial Participants who do print articles must maintain all copyright and other notices on the printed articles.

SIAM Journal Trial Participants may not make SIAM content available electronically to anyone, whether by telephone link or by permitting access through a terminal or computer, or by any other means or arrangement.

Copyright
